PROCLAMATION*by the**President of the Republic of South Africa***No. 2, 2010****PROCLAMATION OF THE CIVIL AVIATION ACT, 2009 (ACT NO.13 OF 2009).**

In terms of section 168(1) and (2) of the Civil Aviation Act, 2009(Act No. 13 of 2009), I hereby determine the 31 March 2010 as the date on which the Civil Aviation Act, 2009 (Act No. 13 of 2009) with the exception of the sections in chapter 4 and 8 listed below, shall come into operation

- (a) **Chapter 4**, section 9 and sections 12 to 14 of Part 1, sections 30 to 41 of Part 3, sections 42 to 46 of Part 4, sections 47 to 63 of Part 5, section 64 of Part 6, section 65 and 66 of Part 7, and sections 67 and 68 of Part 8 of the said Chapter.
- (b) **Chapter 8**, sections 117 to 121 of Part 1 and sections 125 to 127 of Part 2 of the said Chapter.
